This project is broken into three sections which will be awarded as a single project.

- Section 1: CTH TT (CTH N to Ridge Road) & CTH T (Ridge Road to Oak Park Road)
- Section 2: CTH T (Oak Park Road to School Street)
- Section 3: CTH T (School Street to STH 19)

Dane County will be responsible for the following items: Replacing culverts in sections 1 & 2 and excavate and construct base for new curb and gutter and special waterway in section 3. Undercut in sections 2 & 3 will be done by County Forces, if required.

<u>Contractor work on Sections 1</u> will include the following items: Milling Butt Joints & HMA Pavement. HMA pavement will require a Carlson Curb to match existing section at various locations. Milling Butt Joints includes the following locations.

- West End of the Project
- 2 @ Bridge east of Kramer Ct
- 11 Intersections
- 16 Driveways

<u>Contractor work on Section 2</u> will include the following items: Pulverized and Re-laid Pavement and HMA Pavement. In areas of curb and gutter and at butt joints hauling of excess material is the responsibility of the contractor and is incidental to the Pulverized Item. Contractor is responsible for providing squared off butt joints which is incidental to construction.

<u>Contractor work on Section 3</u> will include the following items. Removing Asphaltic Surface (5inches deep), Concrete Curb & Gutter, Concrete Sidewalk, Special Waterway and HMA Pavement. A detail drawing for the special waterway is available in Attachment A. Curb and gutter plans showing areas of new curb and cross-slopes throughout the curbed area is available in attachment B.

Note: Detectable warning fields will not be installed as shown on the plan between Stations 11+00 and 12+00. All curb, special waterway and sidewalk areas will be prepped by Dane County and ready at one time.

All roads will be open to traffic during construction. The contractor is responsible for traffic control signing and flagging during their operations. A minimum of two flaggers are required for all operations. The contractors traffic control is incidental to construction.
