Yes, there is a family/friend package program. No, those sales are not included in the figures provided elsewhere in the RFP.

11.Is the County interested in POS options for commissary sales, such as Vending Machines or commissary Carts?

There is no interest in vending machines. DCSO is open to receiving more information on the commissary carts. Please provide information about this option as part of the proposal response.

- 12. Does the County currently sell "phone time", or is there an interface in place to provide debit calling through the commissary? This is accomplished through the interface with GTL.
- 13. Does the current commissary vendor interface with the GTL tablets? Yes.
- 14.Do all inmates have access to the GTL Tablets? Yes.
- 15. Does the current vendor provide their own internet service? If so, who is the service provider? No, the internet service is provided through the tablet vendor, GTL.
- 16. The RFP states. "The COUNTY wishes to identify commissary services that provide greater efficiencies for day to day operations". Can you provide specifics on the deficiencies of the current operation? No, there are no identified deficiencies but DCSO is always looking for new efficiencies.
- 17. What time of day are the orders currently being delivered to each facility? Is this the county's preferred schedule? The orders are delivered to the inmates between 7am-2pm on Wednesdays. This is the preferred schedule.
- 18. The RFP states, "The CONTRACTOR, at all times, shall maintain a minimum of four (4) employees on payroll, authorized by the Security Services Division to service the Sheriff's Office". Is this the number of employees the current commissary vendor uses to administer the commissary service? Are all employees full-time? The current vendor utilizes part time employees and has at least 4 that have been through the Jail Access training.
- 19. How many days/hours is the training the vendor's staff is required to participate in?

The training is up to 4 hours.

These types of payments include work release and jail diversion at weekly intervals.

- 22. Does the inmate ID bracelet include a barcode? If so, is the barcode of the inmate's ID as it appears in the banking system? Yes, the bracelet includes a barcode, but the barcode is not integrated with the banking system.
- 23. Regarding the following: Allow dietary, religious, gender, age, indigent, debt, day-of-week, or behavioral restrictions on commissary purchases. Please explain the day-of-week restriction. The day-of-week restriction is for discipline when there is a restriction on ordering commissary through a specific time period.
- 24. Regarding the following: Allow printing commissary menus in English and Spanish directly from system. If this capability is made available via the tablet, is it still required for actual printing of order forms? Are order forms currently being printed/used?

While this would be a nice feature, it isn't really a requirement any longer. We typically do not use printed menus.

25. The RFP states, "Any option should support commissary ordering, grievance workflows, medical/dental appointments, inmate handbook, orientation video, PREA and jail information tab at no additional cost to the COUNTY". Are each of these currently being provided/utilized? If so, please advise what is being provided by the commissary provider and what is provided by GTL's tablet program.

None of these items are provided by the commissary vendor. They are all provided by tablet vendor. <u>This requirement is removed from the RFP.</u>

36. Is there any on site space for equipment storage or office space for the contractor?

DCSO currently has a space for the vendor to store that week's commissary order.

37. How long does it usually take for the current vendor to distribute commissary to each facility? How many vendor employees work to distribute commissary on any given day?

The distribution takes 5-6 hours, typically 8am to 1 pm to hand out canteen orders in both buildings (PSB and CCB) with1 deputy escort and the group of canteen workers.

- 39. Item #9000 "Huber Expense Money" can you elaborate on how this is handled? Is this distributed by jail staff? It's a process for the inmate to request their expense money and is distributed by DCSO staff.
- 40. Section 5.2 mentions "Laundry Debit Cards" Could you elaborate this? Laundry debit cards are no longer utilized. <u>This requirement is removed from the RFP.</u>
- 41. Regarding the sales figures on section 11. Are these figures strictly for commissary items or do they include other sales such as phone time, laundry or expense money? See answer #4.

43.Is the Administrative fee paid at the end of the time frames above or prior to?

It is paid at the end of the time frame. DCSO requires payment 15 days after the end of each month of service.

44. With COVID-19, numbers have been down across the board with facilities, it will be very difficult to determine or guarantee the amount you have for your administrative fee, will the county consider having a guarantee of an annual ADP or Monthly ADP's?

DCSO would be open to negation of administrative fee if the population is more than 10% below or above the ten year average ADP of 736 (2010-2020). This could be reviewed on an annual basis with the contracted vendor.

- 45. During the on-site tour/meeting, it was stated that no increases in pricing from what was identified in the proposal. Would the county, to make the guaranteed administrative fee consider raising the pricing? DCSO seeks to limit/ eliminate increases in the cost to the inmate.
- 46. Will Spillman Technology charge to interface with the commissary provider? If so, what is that cost? No.
- 47. Please provide the interface specifications.

The commissary system needs to interface with the Spillman Flex records management system owned by Motorola Solutions. The current version used by the Sheriff's Office is 2019.4 and it will likely be upgraded to a 2021 version in the near future. Flex offers a Data Exchange API which is a web service interface using REST that is based on XML queries and data responses. The interface would pull inmate name, status, and location data on a frequent basis to update necessary information in the commissary system. Network connectivity would be established via a secure VPN. Basic query examples and schema information is available in documentation from Motorola Solutions after the vendor has been selected.

48.Do the inmate ID bracelets have a barcode? If so, what is the barcode font?

#### 49. Is the current Contractor on the county network or their own?

The County network supports the inmate banking and commissary software. The GTL network supports the tablets.

Your request will be reviewed to determine if you meet the criteria. The following criteria is used to determine eligibility:

- You have been incarcerated for 14 consecutive days or more.
- You have been without personal funds (\$5 or less) for 14 consecutive days.
- Your last 3 weeks of commissary orders did not include anything other than hygiene products, medical products, stamped envelopes, golf pencil, lined writing paper or envelopes.

- 73. Section 2.5, Cost Evaluation, includes "Cost 20%." Please clarify the basis for this evaluation: Since there is no commission percentage allowed, does this mean the lowest overall pricing to the inmates? This means lowest overall pricing to the inmates while meeting the County's administrative fee requirement.






### Current Indigent Residents By ID
