The following questions were received and responses are provided:

- 1. The Retiree census we received shows a total of 1,229 Retirees. However, if you refer to Appendix 25 Addendum 1 County of Dane Retiree experience, there are only 815 Retirees who are taking coverage as of March 1, 2021.
 - a. Can we please get an explanation of the discrepancy?
 - b. Is the Retiree census showing all eligible Retirees? The Coverage Type doesn't indicate if there are waivers.
 - c. Can we get clarification as to what the codes mean? It looks like S = single, P = Single + Spouse. What does "K" and "F" stand for.
 - A) The retiree census includes spouses & other covered dependents.
 - B) The retiree census shows enrolled retirees and dependents.
 - C) S = Single, P = Self + Spouse, K = Self + Kid(s),F = Family
- 2. Please confirm the rates shown below for Actives, Retirees, and CARPC since March, 2019 are as follows:

Effective 4/1/19 until 1/1/21

Actives and CARPC – EE only \$46.61 Family \$131.45 Retirees – EE only \$46.61 EE + Sp \$93.22 EE+ Ch \$131.45 Family \$131.45 Effective 1/1/21 until 4/1/21

Actives and CARPC – EE only \$48.94 Family \$138.02 Retirees – EE only \$48.94 EE + Sp \$97.88 EE+ Ch \$138.02 Family \$138.02

We are unclear what the rates that were in effective prior to 1/1/21 are. If this incorrect, please request all rate history going back to 4/1/19. Rates changed on 1/1/2019.

The 2019-2021 rates by tier were:

Active Single: \$48.94 Active Family: \$138.02 Retiree Single: \$48.94 Retiree Employee + Spouse: \$97.88 Retiree Employee + Child: \$97.88 Retiree Family: \$138.02
