BID SPECIFICATIONS

Individual Project Description and Specifications

CTH N (CTH A to US 51) – Town of Dunkirk & City of Stoughton Project No. 67253-1800

This project is to reconstruct/rehabilitate County Trunk N (CTH A north to USH 51).

Dane County work on this project includes the following items: Removing Concrete Curb, Removing Concrete Sidewalk, Excavation, Storm Sewer, Base Aggregate Dense and Finish Grading.

Contractor work on this project includes the following items: Removing Asphalt Surface Milling, Concrete Curb & Gutter, Concrete Sidewalk and HMA Pavement. The CTH A & CTH N intersection will be milled a nominal depth of 2-inches. Between CTH A and US 51the pavement will be milled a nominal depth of 5-inches.

Contractor work will be completed after the County removals, excavation and storm sewer. County work is anticipated to be completed by mid-May. Contractor shall start work within 1 calendar week of notification by Dane County that the County work will be complete.

CTH N north of CTH A and south of US 51 will be closed to thru traffic but open to local traffic during construction. The CTH A intersection will be open at all times. Dane County will be responsible for setting up the road closure and detour route. The contractor is responsible for all other traffic control signing and flagging during their operations. The contractors traffic control is incidental to construction

CTH P (Cross Plains North Village Limits to CTH K) Town of Berry, Section 25, 35-36 Project No. 69254-1800, CHIP Funded

This project is to pulverize and shape the existing pavement and construct a new HMA Pavement. The project starts at approximately Karen Ct. and will end just south of CTH K.

Prior to the Contractors work Dane County will replace culverts, widen the roadway to accommodate the proposed overlay and reconstruct intersections to meet current design standards. County work on this project is anticipated to be completed in early-summer.

Contractor work on this project will include the following items: Pulverize & Relay Pavement, Concrete Curb & Gutter and HMA Pavement.

CTH P will be closed to thru traffic during construction and a detour will be setup under a separate contract for the reconstruction of CTH P in the Village of Cross Plains. The contractor is responsible for all other traffic control signing and flagging during their operations. The contractors traffic control is incidental to construction. The Village and County projects will run concurrently but are independent of one another. Trucking south through the Village Project will be at the discretion of the contractor on that project and approval of the Village.
