SUBJECT: Addendum #1 to Bid# 118065

This addendum contains revisions to bid specifications as well as answers to questions received.

Clarifications/Revisions:

- 1. B-13-462 Replace Traffic Control Work Hour Restriction language with the following:
 - One ramp lane to US 12/18 westbound and one I39 southbound mainline lane of traffic must be kept open at all times. All work must be completed between the hours of 9 p.m. and 5 a.m.
- 2. QMP Mix and Density Testing <u>requirements are waived</u> on the following projects:
 - IH 90 (Bridge Approaches Various Locations): B-13-462, B-13-466, B-13-289 and B-13-438
 - US 12/18 Beltline Highway (Various Locations)
- 3. QMP Mix and Density Testing <u>requirements as written in the bid will be applied</u> to the following project:
 - CTH PQ (Main St "US 12" to West Village Limits) Village of Cambridge

Answers to Questions Received:

- 4. <u>Beltline patches:</u> Some lanes are designated as lanes 2 and 3. How are the 3 lanes designated (lane 1 inside, land 2 is middle, and lane 3 is outside)? Correct
- 5. <u>Beltline patches:</u> Can lanes be closed simultaneously on the Beltline to work on more than one patch per night? <u>Yes</u>
- 6. <u>Beltline patches:</u> The patch located on Whitney Way on lanes #2 &3, can this patch be complete all at once or does it need to be split into two separate patches (due to Traffic Control constraints)?

 This patch will need to be split into two patches.
- 7. <u>I-39/90 and I-94 patches:</u> For those patches that are wider than the lanes, will this need to be split into two patches (due to T.C. constraints)? See specific notes for each bridge.

- 8. <u>I-39/90 and I-94 patches:</u> B-13-289 (at CTH T), is this to be complete in two patches due to width of patch is including the ramp and shoulder? Replace Traffic Control Work Hour Restriction language with the following:
 - 1. Both ramp lanes can be done at one time during the hours of 9 p.m. to 6 a.m.
 - 2. Lane 3 of mainline northbound I39 will need to be closed south of the ramp and ramp traffic directed across the core onto mainline lane 3.
 - 3. If work is done during daytime hours only one lane may be closed at a time.
- 9. <u>I-39/90 and I-94 patches:</u> B-13-438 (I-39 to I-94), is this to be complete in two patches to do the width of the patch leaving no room to divert traffic? Replace Traffic Control Work Hour Restriction language with the following:
 - 1. This work will require two patches with one lane closed at a time.
 - 2. No lane closures are allowed between 3 p.m. and 6 p.m.
